[PROPOSED] AMENDED JUDGMENT

WHEREAS, on July 2, 2025, this Court entered Judgment in favor of Plaintiff Jerry Dagrella ("Plaintiff") and against Defendant Samsung Electronics America, Inc. ("Defendant") in the principal amount of \$24,479.83, plus costs;

WHEREAS, on July 7, 2025, Plaintiff timely filed and served his Memorandum of Costs, claiming costs in the amount of \$2,218.39; and

WHEREAS, Defendant did not file a motion to strike or tax costs within the time prescribed by California Rules of Court, Rule 3.1700(b)(1);

WHEREAS, California Rules of Court, Rule 3.1700(b)(4) states that "[a]fter the time has passed for a motion to strike or tax costs or for determination of that motion, the clerk must immediately enter the costs on the judgment."

NOW, THEREFORE, GOOD CAUSE APPEARING, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that:

The Judgment entered on July 2, 2025, is hereby amended to add the uncontested costs. Plaintiff Jerry Dagrella shall recover from Defendant Samsung Electronics America, Inc. the total principal sum of **\$26,698.22**, consisting of the original judgment of \$24,479.83 plus costs of \$2,218.39.


