Appellant Samsung Electronics America, Inc. ("SEA"), by and through its attorneys of record, respectfully requests a 30-day extension to file its opening brief. This appeal, in part, arises from the trial court's order granting Plaintiff's motion for summary judgment on his third cause of action for negligence, which is based on the alleged negligent conduct of the technician who performed repair services for Plaintiff at his residence on September 4, 2024. The technician is an employee of the independent repair facility, Service Quick, Inc. ("Service Quick"). SEA is presently engaged in settlement discussions with Service Quick regarding its indemnification obligations with respect to the portion of the trial court's judgment that awarded Plaintiff his negligence damages. SEA needs additional time to finalize these settlement discussions because said discussions may result in the payment of the judgment to Plaintiff and the abandonment of this appeal. SEA therefore respectfully asks that the Court grant the requested 30-day extension to provide SEA with sufficient time to potentially resolve the issues in this appeal without the need for further court intervention. See California Rule of Court, Rule 8.811(b) (5).
